

**CITY OF SANIBEL  
RESOLUTION 25-035**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA, APPOINTING SEVEN MEMBERS TO SERVE ON THE SANIBEL PLAN UPDATE STEERING COMMITTEE UNTIL THE CITY COUNCIL ADOPTS AN ORDINANCE AMENDING THE PLAN AND THE COMMITTEE IS DISSOLVED; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Resolution 25-033 established the Sanibel Plan Update Steering Committee and provides that seven members are to be appointed by the City Council and serve until the Committee is dissolved once its recommended amendments to the Sanibel Plan are adopted; and

**WHEREAS**, Resolution 25-033 also provides that the composition of the Committee be as follows: one Planning Commissioner; one Sanibel Captiva Conservation Foundation member; one Sanibel Captiva Chamber of Commerce member (staff or Board member); one Sanibel Community Housing and Resources member (staff or Board member); one Committee of the Islands member; and two citizen-at-large to be appointed by City Council.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA:**

**SECTION 1.** The following persons are hereby appointed to the Sanibel Plan Steering Committee:

Larry Schopp - Sanibel Planning Commission

James Evans - Sanibel Captiva Conservation Foundation

Bob Moore - Committee of the Islands

Nicole Decker McHale - Community Housing and Resources

Calli Johnson - Sanibel Captiva Chamber of Commerce

Jeffrey Muddell - Citizen-at-Large

Eric Pfeifer - Citizen-at-Large

Paul Nichols (Alternate)

Matt DePaolis (Alternate)

The terms of the above members shall commence on July 15, 2025, such members shall be authorized to continue to serve on the Committee until it has rendered recommendations relating to possible amendments to the Sanibel Plan and City Council adopts an Ordinance amending the Sanibel Plan.

**SECTION 2.** This resolution shall take effect immediately upon adoption.
