Upon completion, Please allow 24 hours to fully cure prior to foot traffic, however 48 hours is preferred. Please allow 48 to 72 hours before placing furniture back on the work area as well as any vehicle traffic.

Terms and Conditions:

- Proposal is good for 30 days

- Credit cards are accepted up to \$8000.00

- 50% down payment prior to scheduling; balance due upon completion

- 8% interest per annum will be added to all unpaid balances

Warranty:

The terms set forth in this Agreement are intended as the complete and exclusive statement of the contract and may not be contradicted by evidence of any prior Agreement or oral Agreement. Only a Change Order or an Amendment, signed by both parties, may amend this Agreement. Any changes to this Agreement may be subject to additional charges to the customer.

Concrete Science will complete the work as expediently as possible once started and within the terms agreed to. Concrete Science is not responsible for any delays beyond our control.

This Agreement is the actual order, and it is understood that all items are custom made. Warranty is void with regard to any part or parts of abuse, neglect or accidental causes including, but not limited to fire, flood, acts of God, and war.

Concrete Science will make every reasonable effort, prior to project start, to protect landscaping, walls and adjacent areas and items from damage; however, Concrete Science cannot warranty these areas against possible damage. It is the responsibility of the Customer to protect these areas. Concrete Science is not responsible for any damage to water pumps, filters or skimmers caused by dust or powder residue. If the work area is around a pool, the pool must either be drained or lowered to an acceptable level where we can perform the work required. If you are uncertain of the water level required for your scope of work please discuss with project scheduler when they contact you.

Builder notification: Ramboard or other material to be used throughout home or business to protect other areas prior to project start. Once project is completed, treated surface area must be kept clean from dust and other materials, including walking or driving for the minimum of the time specified in the Agreement.

Concrete Science will install color selected by owner; if owner is not satisfied with their selection, additional charges will apply to change color. Surfaces are unique and may turn out differently at each application. Colors may vary from color charts or illustrations shown. If customer chooses to change color or grip mechanism, additional charges will apply.

If the material applied by Concrete Science loses its bond (peels) due to defective materials or workmanship in the first one year from date of installation, we will repair it at no charge, with the exception of the following:

- There are existing concrete slabs where underlying moisture can cause a chemical reaction in the concrete that could result in blistering or delamination of the concrete coating applied. This is a reflection of the concrete, and not the coating applied. There are multiple causes of this condition that originates at the time the concrete was originally poured. Concrete Science can repair this, but not under the original warranty provided.

- There are no guarantees that cracks will not occur in the coating due to shifting and movement in the concrete that the coating is applied to. Repairs are not covered under this warranty.

- Existing cracks may telegraph through the applied coating.

- Caulking and joint sealant are guaranteed for one year.

- Whitening caused by moisture trapped underneath the surface is not covered by this warranty.

- Clouding, fogging or delamination in the sealer due to excessive moisture intrusion, either from below or on the surface of the finished product is not warrantied.

- Concrete Coatings are films applied to the surface of the concrete to protect or esthetically change the finish. Concrete Coatings are not meant to level low spots or redirect water drainage of any kind.

o NOTE: Metallic floors are a work of art – each floor will turn out unique. Comets, fish eyes and streaking in the Metallic application are to be expected – these can be mitigated by sealing off the area and keeping dust particles and other contamination out of the air while the application achieves its complete dry time.

Concrete sealer is meant to mitigate moisture intrusion, preserving your concrete surface in a freeze / thaw environment. Sealer may appear full after winter or UV exposure – this is normal and is not covered under warranty.

Grind & Seal + Polish:

Concrete Science is not responsible for the exposure of the aggregate contained in the original concrete pour, the final sheen or finish on the surface of the concrete, or the variation in the reflectivity in high and low spots of the concrete. Concrete grinding or polishing will not flatten a wavy concrete floor – Concrete Science does not guarantee that grinding or polishing will flatten, or level, a wavy, pitched or uneven floor.

If any non-recommended or non-authorized maintenance, service or damage occurs by customer or a third party, Concrete Science is not liable for the repairs and the warranty is voided.

Proper care of floor is required - care, cleaning and maintenance sheets will be provided upon job completion.

In the event customer is not the home or business owner, customer confirms that they have received permission to complete the installation and is responsible for completion of the contract terms. Customers who have a Homeowners Association or Board, confirms that they have received approval to move forward with the project installation.

Customer grants Concrete Science permission to photograph the installation process and site and use photographs in print material, online material and campaigns.

Concrete Science is not liable for issues caused by moisture transmission and/or hydrostatic pressure caused by underlying concrete or soil. Vaper barrier may help mitigate moisture transmission; it will not protect against hydrostatic pressure. Customer must notify Concrete Science of any delays or postponement at a minimum of 48 hours prior to scheduled start date (not including weekends). In the event that Concrete Science is not notified at least 48 hours in advance, additional charges may be added to your project.

ATTORNEY'S FEES: The customer must pay any legal fees or costs that Concrete Science incurs in pursuing payment or enforcing the Agreement.

PRE-LIEN NOTICE: THE FOLLOWING NOTICE IS PROVIDED TO YOU AS REQUIRED BY LAW: ANY PERSON OR COMPANY SUPPLYING LABOR OR MATERIALS FOR THIS IMPROVEMENT TO YOUR PROPERTY MAY FILE A LIEN AGAINST YOUR PROPERTY IF THAT PERSON OR COMPANY IS NOT PAID FOR THE CONTRIBUTIONS.

For contracts on a residential property exceeding \$2500.00:
