Thank you for the email. I appreciate having the opportunity to discuss. I felt compelled to respond on social media due to some of the misinformation Mr Sprecher included on the group post.

I have included our City Manager, deputy city Manager and City Attorney in on this email. I did NOT reply all to all council-members due to Sunshine.

Council had previously discussed a 3 way stop on Rabbit road several months ago, that combined with the SUP study looking at moving the bike path crossing to align with Rabbit and San Cap and the wild life study which was presented seemed like a good opportunity to look at traffic options at this growingly impacted intersection . This isnt considered only for those on Rabbit road, but also the communities west of Tarpon which use that corridor to go east and west on San Cap as well as San Cap going west and taking a left on Rabbit.

As you may recall we looked at options a few years ago including rumble strips which was not looked at with favor. What we considered at our last meeting was looking at a short term pilot study with a 3 way stop at that location. We did not give direction on a time frame for install. This was to see the feasibility of this over other potential options which were more permanent.

I cant speak to if the 2 councilmembers should recuse themselves. I will leave the legalities up to our City Attorney . I do know councilmember Johnson and Henshaw voted against it. I did vote in support as a pilot test only. I dont know what I dont know , and I dont want to speculate on any decision to be made by council.

I can say that there was no conversation of lowering a speed limit on San Cap. This seems to have gained traction on social media and is inaccurate. There was discussion east of the 4 way on Periwinkle to the light house in terms of reduced speed as the bridge height is going up a foot and there are FDOT suggested speeds for line of sight. That made have been some confusion. I indicated in my response, it's important that we all work with the facts. I do encourage you to listed to the meeting, you may have already done so.

I am meeting with city Manager Souza tomorrow for my briefing and will further discuss. I certainly do not support any slower speed limit- on San Cap .

I certainly have not made any final judgement on an unknown. I can assure you for my tenure on council I work hard everyday to do the right thing for everyone. I volunteer and do not have a business interest on this island. I do my research deeply on items which come before us. These 3 years have been trying for all of us. Im proud of what we have done, all of council and staff - to make life better on this island in the most challenging times we will face.

We will continue to do so. Please feel free to give me a call if you need to discuss further, this or any other topic. I do appreciate conversation with each other, versus through social media.
