Dear Chief Barbot,

This letter establishes a mutually beneficial arrangement between the City of Sanibel Recreation Department and the Sanibel Fire Rescue District (District) with the provisions of the arrangement listed below:

- The Sanibel Fire District agrees to provide monthly complimentary blood pressure screenings at the Sanibel Recreation Center at mutually agreed upon date and time; crew shall be subject to emergency call.
- The Sanibel Fire District agrees to participate in community events in partnership with the Recreation Department so long as this does not affect the normal operation of the District.
- The Sanibel Fire District agrees to assist with filling the Sanibel Recreation Center pools with water and the changing of the flagpole light bulb as needed for maintenance purposes so long as this does not affect the normal operation of the District.
- In consideration of the services and contributions set forth above, the employees of the Sanibel Fire Rescue District will be eligible to receive individual annual memberships at the rate of \$110.00. The membership privileges at the Sanibel Recreation Center are for a period not to exceed one year from each employee's application approval. This membership is for individual employees only. If the employee chooses to upgrade to a family membership, the additional cost between the individual rate and the family rate in effect at the time will be paid by the employee.
- The City of Sanibel Recreation Department will issue three (3) memberships to the Sanibel Fire District household to be used by on-duty staff only.

This arrangement will be effective on the terms and conditions set forth above from July 15, 2025, for a period of two (2) years (although employee membership will extend one year from application approval as noted above). The City appreciates the efforts of the Sanibel Fire Rescue District to provide wellness benefits to its employees through the Sanibel Recreation Center.
