CITY OF SANIBEL RESOLUTION 25-074

A RESOLUTION OF THE SANIBEL CITY COUNCIL SITTING AS THE SANIBEL EQUALIZATION BOARD; EQUALIZING AND APPROVING A RECURRING ANNUAL SPECIAL ASSESSMENT TO FUND THE DREDGING OF THE SANIBEL HARBOURS INLET DREDGING ASSESSMENT DISTRICT; EQUALIZING AND APPROVING THE RECURRING ANNUAL SPECIAL ASSESSMENTS FOR FISCAL YEAR OCTOBER 1, 2026 THROUGH SEPTEMBER 30, 2027; PROVIDING FOR THE CONFIRMATION, ADOPTION, AND FILING OF A FINAL ASSESSMENT ROLL FOR SAME; PROVIDING FOR CONFIRMATION OF THE RECURRING ANNUAL SPECIAL ASSESSMENT FOR FUTURE YEARS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Sanibel pursuant to its Home Rule Power, general law, including without limitation Chapters 166, 170 and 197, Florida Statutes, and the Sanibel Charter has determined to levy a recurring annual special assessment to fund the dredging of the Sanibel Harbours Inlet; and

WHEREAS, such levy has been made for the Fiscal Year October 1, 2026 through September 30, 2027, on the Assessed Property as described in City of Sanibel Resolution 25-073, adopted this date; and

WHEREAS, the City Council has thereafter met as an equalization board pursuant to Section 170.08, Florida Statutes, and has heard and considered any and all comments or complaints as to the special assessments and has adjusted and equalized assessments on a basis of justice and right; and

WHEREAS, the equalization board has made the adjustments, if any, set forth in Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF

SANIBEL, FLORIDA:

SECTION 1. The recurring annual special assessment to fund the dredging of the Sanibel Harbours Inlet Dredging Assessment District as set forth and described in Resolution 25-061 adopted October 7, 2025,, which is hereby incorporated by reference, with such assessment levied pursuant to Resolution 25-073 adopted this date, which is hereby incorporated by reference, is hereby confirmed, **APPROVED**, and **ADOPTED**.

SECTION 2. Adjustments, if any, to the Assessment Roll, approved by Resolution 25-064 are set forth on Exhibit "A", attached hereto and incorporated herein.

SECTION 3. A Final Assessment Roll, attached hereto and incorporated herein as Exhibit "B" which shall constitute the Final Assessment Roll, is hereby confirmed and adopted for Fiscal Year October 1, 2026, through September 30, 2027, and shall forthwith be filed with the City Council in the office of the City Clerk. The recurring annual special assessment and Final Assessment Roll described herein, is **CONFIRMED** and shall stand as a legal, valid, and binding first lien upon the property against which such assessments are made until paid. Such Final Assessment Roll is further approved, adopted, assessed, and levied for all future fiscal years unless and until amended or updated by Annual Assessment Resolution of the Sanibel City Council as more particularly described in Resolution 25-073. In all future years

such assessments shall stand as a legal, valid, and binding first lien upon the property against which such assessments are made until paid.

SECTION 4. Effective Date. This resolution shall take effect immediately upon adoption.
