SUBJECT: Periwinkle Way Milling and Resurfacing Project

1. Consider approving a contract with Southern Striping Solutions, LLC in the amount of \$1,371,949.79 for the Periwinkle Way Milling and Resurfacing Project and authorize the City Manager to execute the contract. Funds are available for these construction services through a combination of a Florida Department of Transportation (FDOT) Grant 454841-1 and Florida Department of Environmental Protection (FDEP) Grant HA017.

BACKGROUND: Hurricane Ian impacted Sanibel Island in September of 2022 and caused significant damage to infrastructure island wide including the City's public road system. Damage was caused by standing saltwater storm surge and excessive use of the roadways from heavy construction vehicles reducing the lifespan of public road asphalt and pavement markings. The resurfacing of public streets is an integral part of the City's infrastructure maintenance program. The surface of arterial roads, such as Periwinkle Way, have an expected lifespan of 10 years, while collectors have anticipated lifespans of 12 years and local roads 15 years. The timely resurfacing of roads reduces the likelihood that a road will need a future full reconstruction, which is significantly more expensive than resurfacing.

The Periwinkle Way Milling and Resurfacing Project includes milling and resurfacing of Periwinkle Way from approximately 500 feet west of Casa Ybel Road to approximately one-third of a mile east of Donax Street. The proposed awarded project will include a bid additive alternate for drainage swale repairs to the north side of Periwinkle Way at Palm Street, Fitzhugh Street and Main Street.

CONSTRUCTION: An Advertisement for Bids for the project was placed in the May 25, 2025 edition of the Fort Myers News-Press. In response to the ad, one contractor submitted a bid which was opened and read aloud on June 26, 2025 in the presence of Mike Dahl of Southern Striping Solutions, LLC and Jason Goodrich and Scott Krawczuk from the City. As per the attached Bid Tabulation, the low bid was submitted by Southern Striping Solutions, LLC in the amount of \$1,371,949.79 including bid additive alternate item related to drainage repairs.

FUNDING SOURCE: Funding requirements for the project are discussed above. The funding summary table is shown below.
