



Dear Sanibel Planning Commissioners,

I am writing as a Sanibel resident and business owner in opposition to the Conditional Use Permit Application submitted for Unlimited Biking, an international formula retail store, to rent 100 eBikes from Unit 3 of the Islander Center on Periwinkle Way.

Five years ago the Planning Commission determined unanimously and unambiguously that the Islander Center was not safe for operation of a bike rental business that would have consisted of 70 non-electric bicycles. Five years later the same applicant is back – acknowledging, this time, that it is a formula retail business – and asking for 150 rental bikes, including some number of e-bikes. Staff this time supports 100 rental bikes at that location, notwithstanding the unanimous safety findings by the Commission five years ago.

1. The Islander Center at 2407 Periwinkle is not a safe location for a steady stream of bicycle renters to test-drive bikes in a small, multi-tenant parking lot, and then to egress/ingress onto the heavily trafficked SUP on Periwinkle Way. It was unanimously deemed unsafe by the Commission five years ago, when this same company applied for a smaller number of bicycles at this same location – and it is no safer today. Indeed, with the addition of faster, heavier electric bikes to that location, it is less safe today.

According to the Final Meeting Minutes of the February 9, 2021 Planning Commission hearing on the matter [at pp 10-11], “Commissioners detailed various concerns, including internal compatibility with other uses on the same site, inadequacy of parking, safety concerns for bicycle renters related to fitting and testing of rental bikes in a parking lot with high traffic flow, [and] safety concerns for bicyclists having to ingress and egress to a business in the middle of a shopping center with restaurants and other businesses with high traffic flow”

These were not passing concerns; these were concerns that Commissioners believed could not be remedied by any changes: Several Commissioners voiced “concerns that the Commission believed

should have made staff not support the request, not being aware of any changes that could be made to make this particular site acceptable for this use, and that enough information had been provided during the hearing and through site visits to make a decision.” [Minutes at p. 12] [emphasis added]

The recent removal from the LDC of the technical parking requirements for commercial properties does not render this location less unsafe for operating a bicycle rental business. The safety findings of the Commission in 2021 related to the nature of a bicycle rental business – which entails customers being fitted for bikes and road-testing bikes in a parking lot; and related to the location of such a business in a cramped parking lot servicing multiple other businesses with high traffic flow – with ingress and egress of bicyclists (many of them inexperienced). These concerns are inherent to that type of business in that specific parking lot no less now than in 2021. (Presently there is no restaurant at that location, but with an existing CUP for a restaurant there presumably will be again.)

The applicant states in its letter to the City of Sanibel that “we expect approximately 65% of our rentals will be delivery-based, serving residential homes, vacation properties, and local hotels.” That leaves a minimal expectation of 35% of its 100 rental bikes that will be serviced in person from the Islander Center.

And it is likely to be a greater in-person rate than 35%. It is noteworthy that of the “16 cities worldwide” locations listed on the applicant’s website, 15 are exactly that: cities. Sanibel is much different geographically and demographically than New York, London, or Paris. There will likely be a greater percentage of walk-ins by Sanibel customers, given the visible location of the Islander Center near the busy intersection of Periwinkle Way and Palm Ridge Rd on a small island.

In addition, much of Unlimited Biking’s website marketing emphasizes its in-person guided tours: “Unlimited Biking has grown to include sixteen cities worldwide, over eighty guided tours, and millions of people choosing to explore with Unlimited Biking”. Guided tours from the Islander Center would add a significant traffic load of cars arriving for tours, and an increased load of bicyclists congregating in that parking lot testing, egressing, and ingressing as part of the tours.

2. Bringing onto Sanibel one of the largest bike rental chains in the country is detrimental to the local bike rental businesses, and is inconsistent with the the Sanibel Plan and the City of Sanibel Mission Statement.

The Sanibel Plan emphasizes the island’s small-town charm and a community living in harmony with the island’s wildlife. In the Plan’s Hierarchy of Values, “Sanibel will serve as attraction only to the extent to which it retains its desired qualities as sanctuary and community.”

The environment and community of Sanibel have been hit with once-a-century threats in recent years. It has been a financial, administrative, and emotional struggle to rebuild our homes and businesses – and for many small business owners, to bear the several-year costs of re-opening into a tourist-driven economy with very few tourists. It has only been in the last few months that we have seen business volumes return to levels near what they were in 2022.

It does not serve our community that while we are struggling to retain our desired qualities as sanctuary and community, Planning Staff is supporting an application by one of the largest bike rental businesses in the country to capitalize on our nearly-rebuilt tourist economy – as part of an application that was unanimously and unambiguously rejected just five years ago as being unsafe at that very location.

The City of Sanibel Mission Statement states that Sanibel stakeholders will "promote economic stability, strengthen community engagement, and provide exceptional services and governance." It does not "promote economic stability" to undermine the island's existing bicycle rental businesses, who have been slowly pulling themselves back up after surviving catastrophic losses. And it does not "strengthen community engagement" to erode the economic foundations of Finnimore's Bikes or Billy's Bikes, who generously support our island's nonprofit sector and community activities, who assisted the community with free bicycles immediately following Hurricane Ian, and who have retained and paid staff these past years to remain open in the midst of a slowly recovering economy.

I am a co-owner of the newest, and smallest, local bike rental company designed primarily to facilitate bikers through the Ding Darling, Captiva, and Bowman's Beach. We are about to launch our new business, having been permitted a total of 20 eBikes at a location well away from the main commercial district. The entry into the field of Unlimited Biking would dramatically and negatively affect our start-up.

3. The consistency and reliability of City interpretation of the Land Development Code is called into question in these circumstances. Although it is true that there is no principle of *stare decisis* with decisions rendered by the Planning Commission, it is also true that there must be some reliable standard of consistent application of the Code – and due respect by Planning Staff to decisions by the Planning Commission. Five years ago the Commission came to a unanimous decision concerning the same applicant at the same location, and unequivocally deemed that location unsafe for a bicycle rental business and incapable of being cured as a safe location for a bicycle rental business. For the Planning Department to nevertheless support this nearly identical application five years later calls into question the finality of Planning Commission decisions interpreting the Land Development Code, and the reliable consistency of applying those interpretations to a nearly identical case.

4. Finally, Sanibel may not be prepared for the sharp increase in Class 2 and Class 3 eBike users on its shared use paths that would come with an international rental chain in the thick of Periwinkle Way. Just two weeks ago City Council decided to move forward an ordinance authorizing Class 2 and Class 3 eBikes on Sanibel's shared use paths. During that Council session it was acknowledged that there would inevitably be a resulting increase of eBikes on the SUP, and an accompanying increase of safety risks to other users of the SUP (pedestrians and other cyclists, particularly older people, children, and pets). But it was felt that there was a greater safety risk in requiring Class 2 and Class 3 eBike cyclists to ride on Sanibel roadways, which do not have sufficient shoulder space to readily accommodate cyclists.

As the City adjusts to an increase in eBike traffic on its SUP, it is important that local bike shops – who are local stakeholders with a vested interest in the safety of our community – demonstrate the concern and responsiveness to the interests of Sanibel residents. Now is not the time to unleash a Big Bang of eBikes on the SUP by situating in the Town Center General one of the country's largest bike rental

operations. A business that implicates public safety is not one that should be entrusted to a national chain business, whose profits and decision-making authority reside elsewhere.

For all these reasons I urge the Commission to vote no to this application.

Dear Ms. McMichael:

I am a full-time Sanibel resident. I live on the SUP and I am also an almost daily user. I use a traditional bicycle. In the last two years, there has been an explosion of e-bikes on the path, and it is inevitable that over time a majority of residents will switch to them. It is now MUCH more important to pay very close attention to who is approaching both from the front and the rear, even on my traditional bicycle (and I am sure it is much worse for walkers). Regardless of the rules, e-bikes simply make traffic move faster on the path, and caution and courtesy by many users has gone out the window.

I understand the physical need for some people to have e-bikes, and they are certainly convenient for anyone. Still, they add NO value to the overall "Sanibel vibe" on the SUP. They mainly serve as an alternative for their riders to avoid being backed up in traffic on the roadway.

There is NO WAY we should ever allow for another 150 e-bikes to be added to the SUP. Especially because the main users of those e-bikes would be visitors, that might have less concern about our SUP rules, speed limits, etc. Ideally we would even limit the total number of e-bikes that Billy's and Finnimore's are allowed to rent (but I realize this is probably not realistic).
