This amended notice of violation amends the notice of violation previously sent to you, dated December 15, 2023. This notice is to inform you that a violation of the ordinances of the City of Sanibel has been found to exist at the above location. This violation is in the form of work completed or underway without the required City Permits which may be violations of the 2023 Florida Building Code and applicable floodplain regulations. The work believed to be completed without a necessary permit includes siding, windows, stairs, and ground floor renovations to space significantly impacted from the storm surge of Hurricane Ian on September 28, 2022. Specifically, FEMA has identified your property as having possible violations, and the City of Sanibel has been directed to "verify, monitor, and resolve the possible violation." Unpermitted work of this nature could be in violation of Sanibel Code Sections 94-51, 94-81, 14-5, 14-186, 14-187, and 14-188. Additionally, the floodplain administrator has also requested to inspect the subject premises to determine if other development has been undertaken without issuance of a requisite permit in violation of FEMA flood regulations administered by the City, as the subject premises is in a special flood hazard area. Those requests have been rejected to date and such rejection constitutes a violation of Sanibel Code Section 94-81. The City Code section(s) cited as a result of these violations are indicated in the attachment and this notice serves as a written order to achieve compliance:

**HOW TO COMPLY:** You are directed to abate the cited violations immediately by carrying-out the following compliance actions:

- 1. You or your authorized agent are directed to apply for and receive the required permits from the City of Sanibel for the work completed.
- Schedule an inspection with the floodplain administrator to determine whether other unlawful development has been undertaken without issuance of a permit in violation of FEMA flood regulations administered by the City.

#### 2023 FBC, 8th Edition - Chapter 1, Section 102.2 Building

102.2 Building.

The provisions of the Florida Building Code shall apply to the construction, erection, alteration, modification, repair, equipment, use and occupancy, location, maintenance, removal and demolition of every public and private building, structure or facility or floating residential structure, or any appurtenances connected or attached to such buildings, structures or facilities. Additions, alterations, repairs and changes of use or occupancy group in all buildings and structures shall comply with the provisions provided in the Florida Building Code, Existing Building.

#### Sanibel Code Sec. 94-51. - Permits required.

Any owner or owner's authorized agent (hereinafter "applicant") who intends to undertake any development activity within the scope of this chapter, including buildings, structures and facilities exempt from the Florida Building Code, which is wholly within or partially within any flood hazard area shall first make application to the floodplain administrator, and the building official if applicable, and shall obtain the required permit(s) and approval(s). No such permit or approval shall be issued until compliance with the requirements of this chapter and all other applicable codes and regulations has been satisfied.

#### Sanibel Code Sec. 94-81. General.

Development for which a floodplain development permit or approval is required shall be subject to inspection.

#### Sanibel Code Sec. 14-5. - Violations.

The following acts are unlawful and prohibited:

(1) Beginning or continuing the construction of any building, structure or system regulated by this chapter without first obtaining all required permits and paying all fees and charges for those permits.

#### Sanibel Code Sec. 14-186. - Qualifications for issuance.

- (a) The building official shall issue a permit under this chapter only to a person who is in possession of a current and valid license, certification, registration, or competency approval, or to a person who is acting within the scope of an exemption provided in general law or this chapter.
- (b)A person seeking a permit under this chapter shall file with the building official, and pay the fee for, an application for the appropriate permit. The application shall be on a form provided by the building official, and shall contain plans and specifications required by the building official sufficiently detailed as to describe the work and to exhibit compliance with construction standards. The building official may require the submission of more than one set of plans and specifications.
- (c)When required, the applicant or agent thereof shall not begin construction or other work until the building official has issued the appropriate permit and posted it at the building site.

#### Sanibel Code Sec. 14-187. - Conditions for requirement.

- (a) An applicant shall obtain a building permit for building projects valued at more than \$750.00.
- (b) An applicant shall obtain a roofing permit for roofing projects valued at more than \$250.00 and for any new installation or addition regardless of value.
- (c) An applicant shall obtain a lawn sprinkler permit for lawn sprinkler projects valued at more than \$250.00, and for any new installation or addition regardless of value.
- (d) An applicant shall obtain an electrical permit whenever electrical wiring, either temporary or permanent, is installed, removed or extended, except when the electrical work, excluding the appliance or equipment, but including all material

and labor, is less than \$250.00. This exception does not apply for electrical work requiring a development or sign permit, or involving a service change, disconnection or addition of circuits.

- (e) An applicant shall obtain a plumbing permit whenever piping or appliances, either temporary or permanent, are installed or extended, except when the plumbing work, excluding the appliance or equipment, but including all material and labor, is less than \$250.00. This exception does not apply for plumbing work requiring a development permit, adding a main water service backflow device, replacing a water service supply, replacing a wastewater line, or repairing/replacing a septic system.
- (f) An applicant shall obtain a mechanical permit whenever a new system is installed or when a major component such as a compressor or air handler is moved or replaced. The applicant need not obtain a mechanical permit when there is only a change in duct work.
- (g) An applicant shall obtain a gas permit whenever a new system or piping, either temporary or permanent, is installed, removed or extended.
- (h) An applicant shall obtain a moving permit whenever a structure constituting an oversized load under state traffic laws is moved on either a public or private street. If deemed necessary to determine the condition or safety of the structure, the building official may require a relocation inspection.

#### Sanibel Code Sec. 14-188. - Building permits.

- (a) Validity. A building permit shall remain valid and the construction or other work authorized by it shall be completed in accordance with the following requirements:
- (1) First structural inspection. Within 60 days after the issuance of the permit, the applicant or agent thereof shall complete work to a point where it is ready for a first structural inspection. The applicant must make a request for such inspection within this time period.

- (5) Additional extensions. Any extensions in addition to those provided in subsection (a)(4) of this section shall only be granted by the city manager, upon the written request of the applicant, and upon a showing that the delay was unavoidable, that progress is being made in accordance with a schedule, and a finding that the public interest will not be injured by the granting of an additional extension of the permit. The city manager may conduct a hearing on the application, refer it to the assistant city manager or to an independent hearing officer, or refer it to the construction industry regulation board to hear the request. If referred to the construction industry regulation board may hear the request or refer it to an independent hearing officer for hearing and determination.
- (6) Limitation on extensions. No extension of a building permit shall extend beyond the expiration date of any development permit.
- (7) Fees for requests for extensions. Fees for requests for extensions are set forth in section 14-191

### STIPULATION FOR AGREED CODE ENFORCEMENT ORDER AS PREPARED ON APRIL 10TH, 2024

The undersigned Petitioner and Respondent(s) (hereafter referred to collectively as "Respondent") hereby stipulate and agree to the entry of an agreed code enforcement order as set forth in this stipulation:

#### A. AGREED FACTS:

- 1. The City of Sanibel Code Inspector initiated these proceedings.
- 2. The respondent received adequate notice of the violation. The Notice of Violation 2023-649 alleged the existence of violations of the City of Sanibel Ordinance, specifically Sanibel Code Sections: 1-15, 14-5, 14-186, 14-187, 14-188,94-81, 94-82, 94-83.
- 3. The Respondent admits to the violations. The Respondent agrees to comply with the Notice of Violation, abate the violation, and to do the following, by: MAY 13<sup>TH</sup>, 2024
- PAY THE PETITIONER'S COSTS IN THE AMOUNT OF <u>\$ 202.83 BY MAY 9<sup>TH</sup></u>, 2024
- □ CORRECTING THE VIOLATION BY: <u>Apply/ obtain permits with the building department and have approval with Chief building official.</u>
- TAKING & FULLY COMPLETING THE ACTIONS DESCRIBED ABOVE:
- 4. If respondent fails to abate the violation by the deadline determined by the Hearing Examiner with each of the foregoing, a fine in an amount determined by the Hearing Examiner, shall be imposed against Respondent by separate order without further notice to Respondent. The fine shall be calculated beginning as of the date of this Stipulation and continuing until the violation is abated as set forth herein.

5. The undersigned has the authority to make this stipulation on behalf of the Respondent (s) and Petitioner.

#### **B. AGREED LEGAL ISSUES**

- 1. These proceedings are pursuant to the Local Government Code Enforcement Board Act, Chapter 162, Florida Statutes.
- 2. The Hearing Examiner has the authority to impose administrative fines and other non-criminal penalties to provide an equitable, effective and inexpensive method of enforcing any codes and ordinances in force in counties and municipalities, where a pending or repeat violation continues to exist.
- 3. Petitioner has prevailed in prosecuting its case and according to Section 162.02 (2), Florida Statutes, Petitioner is entitled to recover all costs in prosecuting the case which shall be included in the lien authorized by Section 162.09 (3), Florida Statutes.
- 4. Respondent's violation of any of Sanibel Codes Sections described in the Notice of Violation within five (5) years shall be a repeat violation as defined by Section 162.04 (5), Florida Statutes.

Upon recording this Order in the Public Records, this Order shall constitute a lien against all of Respondent's real and personal property, including but not limited to the subject property described herein, and subsequent foreclosure of the lien may result in the loss of such property.

IF THE PROPERTY OWNER CORRECTS THE VIOLATION, PAYS CITY COST, SIGNS AND RETURNS THIS STIPULATION AGREEMENT BY MAY 9<sup>TH</sup>, 2024 THE HEARING WILL BE CANCELLED.
