

#### **CURRENT RAINFALL AND CLIMATE OUTLOOK**

SFWMD District rainfall for November 2023 is <u>above normal</u> at 3.88" (205% of normal). This was due primarily to rainfall on November 15, which varied widely across the district from the Lower Kissimmee at 88% of normal to Everglades National Park at 537% of normal. <a href="https://www.sfwmd.gov/weather-radar/rainfall-historical/monthly">https://www.sfwmd.gov/weather-radar/rainfall-historical/monthly</a>

For the 2023 rainy season (June 2-Nov 1), the SFWMD received 33.3" of rain, which is 94% of normal. The Southwest Coast, Everglades National Park, and the Upper Kissimmee were the driest regions at 71%, 76%, and 83% of normal, respectively. https://www.sfwmd.gov/weather-radar/rainfall-historical/seasonal

The three-month outlook for Dec-Jan-Feb 2023-24 indicates a 60-70% chance of above normal rainfall for south Florida.

NOAA ENSO Report (updated on 11/27/2023):

- El Niño conditions are observed.
- Equatorial sea surface temperatures (SSTs) are above average across the central and eastern Pacific Ocean.
- El Niño is anticipated to continue through the Northern Hemisphere spring (with an 62% chance during April-June 2024).

#### **ALGAE BLOOMS**

**Red Tide:** FWC Red Tide Update for November 21, 2023

The red tide organism, *Karenia brevis*, was observed at background concentrations in one sample collected offshore of Southwest Florida (Monroe County) over the past week. Other samples collected statewide did not contain *K. brevis*.

There were no reports of fish kills or respiratory irritation suspected to be related to red tide received in Florida over the previous week.

Blue-Green Algae: DEP Weekly Update (November 9-16, 2023)

There were 15 reported site visits in the past seven days with 15 samples collected. Algal bloom conditions were observed by samplers at three of the sites.

Satellite imagery from 11/11 shows low to moderate bloom potential on approximately 10% of Lake Okeechobee, primarily in the southwestern portion of the lake. Satellite imagery from 11/11 for the Caloosahatchee and St. Lucie estuaries shows no bloom potential on visible portions of either estuary.

11/10,11/15-11/17, 11/21-11/23

Trichodesmium: No reports

Sargassum: No reports

    - No change to the Water Control Plan; but policy considerations still be discussed between USACE and NMFS and elevated to senior leadership for resolution
