Re: Opposition to Expanded Offshore Drilling in the Gulf of America

Dear Senator Moody:

The Sanibel City Council respectfully submits this letter in opposition to the federal plan to expand offshore oil and gas drilling in the Gulf of America. The risks associated with offshore drilling pose an unacceptable threat to Florida’s coastal environment, economy, and way of life.

A spill off Florida’s coast could devastate fragile ecosystems, tourism-based economies, and the quality of life our residents and visitors cherish. Accidents can and do occur—NOAA responds to more than 150 oil spills each year. The 2010 Deepwater Horizon disaster released over 3.19 million barrels of oil into the Gulf, resulting in \$8.7 billion in fishing industry losses and the deaths of countless marine animals. Despite recovery efforts, millions of gallons of oil remain in the marine environment, and the long-term impacts of this disaster are still not fully understood.

Expanding offshore drilling is unnecessary and inconsistent with current energy trends. This year, global renewable energy production surpassed coal and gas for the first time, reflecting rapid growth in clean energy technology and innovation. In addition, 77 percent of offshore oil and gas leases are not producing, calling into question the need for new leasing. Expansion into currently protected areas would also interfere with critical military training and testing activities in the Gulf.

For Southwest Florida, the risk is particularly acute. The Gulf Loop Current could carry oil directly to our shores, threatening an economy where tourism generates approximately \$3.5 billion annually in Lee County alone. A single spill could cause lasting harm to our coastal communities and regional economy.



Thank you for your consideration of our concerns and for your service representing the State of Florida in the United States Senate.


