Dear Mick,

Thank you for the opportunity of meeting this morning with myself and Jason LaManna, treasurer Sanibel Dog Club, regarding our desire to establish a Dog Park on Sanibel.

We understand that the agenda is full for the May 6 City Council meeting but that you will determine a date and time in the near future for the Sanibel Dog Club to present its case to the Sanibel City Council.

We also understand that there are major objections to Gulfside Park for the location of the Sanibel Dog Park and, in fact, there are problems with all of the potential sites of City property because all such land is deemed "environmentally sensitive". In addition to the benefit of such a park for dogs and their owners, we believe that a dog park would actually enhance the environmental quality of our land as there would be a policy of waste cleanup enforcement. We also believe that this could be a revenue generator for the City, with increased dog licensure and a fee required for use of the Park.

It is our goal that the City Council approve the establishment of a Dog Park on Sanibel at this meeting and direct the City Manager, Natural Resources, Planning Commission and City Attorney to work with Officers of the Sanibel Dog Club to determine a location which is appropriate, with the understanding that this site would probably require a City-wide Referendum for its final approval. The Sanibel Dog Club would be willing to fund this Referendum, as well as all costs related to the establishment and maintenance of the Park.

Please share this letter with your colleagues on City Council and the City Manager.

RE: Proposal for Dog Park at Gulfside Park

A group of citizens on the island have proposed a dog park at Gulfside Park at the south end of Algiers Lane. Although there may be an appropriate location on the island where a dog park would have a minimum environmental impact, Gulfside Park is not it. The primary environmental issues associated with dog parks are:

- 1) Despite best intentions, signage and provided refuse bags, dog waste is not all removed by users which results in sanitary issues, including potential threats to human health, and problems with polluted run-off and contaminated ground and surface water during rain events. This problem can be easily observed first hand at any of the existing Lee County dog parks.
- 2) The fencing required to allow for free-roaming dogs to use a park and the dogs' natural predatory instincts precludes any significant use of a dog park by wildlife. Protecting wildlife habitat and promoting co-existence with wildlife is a basic tenet of the Sanibel Plan which would be impossible to meet at such a fenced-in park.
- 3) Activities of the dogs themselves including digging, running through and trampling of vegetation, and prodigious urination on trees and bushes especially by male dogs in the presence of other dogs, results in the loss of virtually all shrubs and all but the most hardy trees at fenced-in dog parks (see County sites).

Gulfside Park as a beach park is immediately adjacent to the Gulf of Mexico and groundwater leaching from the park could be expected to directly enter the Gulf during the rainy season and after rain events. The coastal waters surrounding Sanibel continue to have threats from over-nutrifcation and bacterial contamination and anything that could serve to contribute to this problem such as a

Thank you for the opportunity to allow us to provide the Council information regarding our request for a Dog Park on Sanibel. The following is in response to your letter dated April 16, 2008:

Item #1: Identification of a location for a Dog Park that protects Sanibel Wildlife and Vegetation, provides adequate parking, water service, and is not a nuisance to neighbors.

Although the Club would be open to any Island location, we feel that Gulfside City Park is the best option. The park area (away from the beach) is rarely used, is a good distance from residences, has an easily available water supply, and a large parking area. I live in a neighborhood near the Park and rarely see more than a 6-8 cars in the lot accept on peak vacation weeks, i.e. Winter break and Easter week. Even on those weeks, I have never seen anyone using the park area, only the beach. We believe that a Dog Park could actually increase parking revenues for this lot. With regards to wildlife, the proposed Dog Park would use only about ½ of the park area and whatever animals are there could easily go around the fenced area. There do not seem to be any gopher tortoises or other animals in the park. With regards to vegetation, there are many fire ants and burrs in the area which is probably one reason that it is rarely used. Gulfside City Part is not an area of wild vegetation but has planted grass which the City currently mows every other week.

Item #2: A plan to manage feces and urine generated at a Dog Park.

Our members have done substantial research of other dog parks in our area and in other regions of the country. We have also utilized on-line resources that document best-practices for dog park management. We have learned that multiple waste-scoop devices with large covered receptacles not only permit better clean-up but it is environmentally friendly as there is no need for the many small, single-use waste bags. This is consistent with the "Green Team" at the Sanibel School who are trying to reduce our use of plastic bags. Clean-up of feces WILL be a requirement for all users of the park. As for urine control, we have found that mulch ground cover not only captures and dries the urine but can eliminate much of any residual odor. Our Dog Club volunteers will monitor clean-up activities and provide weekly Park maintenance.

Item #3: A plan as to who will be responsible for enforcing Dog Park Rules and Regulations.

The Sanibel Dog Club now has 107 dues-paying members, the majority of which are residents of Sanibel. Our members are willing to provide scheduled volunteer time to monitor the park's use, document any violations and work with City Police to report and enforce not only the rules of the Park but violation of any dog related activity on the Island. One of our main goals for the Park is to provide a place for dogs to run off-leash so that owners do not use the beach or other unsecured public/private areas to do so.


Attached, please find the following documents:

- a) An aerial view of Gulfside City Park with a proposed layout of the Dog Park area. This demonstrates that there would be plenty of space remaining for other park users, is away from the beach and provides a secure double-gated system.
- b) An artist's rendering of the proposed Park (not to scale)
- c) The project plan for development
- d) A budget for development and maintenance
- e) A summary of our recent petition drive demonstrating overwhelming support for the park from both island visitors and homeowners
- f) A recent article from the News-Press which highlights benefits of a community Dog Park.

Finally, since forming the Sanibel Dog Club we have learned that few residents and dog owners are aware of the City's licensing requirement, many dog owners allow dogs off leash in public spaces, including the beach, because there is no other place to do so, and many visitors with dogs are unaware of local ordinances pertaining to their dogs. A Dog Park on Sanibel gives Club members a place to safely allow dogs off leash, educate others on Sanibel's unique environment and provide additional traceable revenues via increased dog licenses and Dog Park user fees, if required for gate security purposes (resident and visitors). These also would allow the City to track park usage.

We thank you and the Council for making room for us on an upcoming Council Meeting Agenda. We are prepared to make a brief PowerPoint presentation and talk about the issues related to a Dog Park on island.

Dog Park Petition Summary

The petition drive was done over a four week period from late March to early April. The drive was done via solicitation in retail areas, neighbor-to-neighbor communication and posting of information in local retail establishments. The following is a summary of the results:

Total number of signatures collected:	1,512
Total number of positive/favorable responses:	1,520
Total number of negative/non-favorable responses:	2
Total number/percentage of Sanibel homeowners responding:	902 / 59.66%
Total number/percentage of visitors responding:	610 / 40.34%

Petition notes:

The overwhelming feeling of residents, property owners, businesses and visitors is that a Dog Park would be a positive addition to the Island. Most Island dog owners feel there is little space for their pets to run off-leash. Many visitors were either amazed that we, as a wildlife-centered community, didn't have a dog park or upset that there was nowhere for them to allow their pets to run.

We met very little resistance in our petition drive. The two negative responses seemed to be related to a misunderstanding that the dog park would be on the beach or that it would be an unsafe/unfenced environment.

Dog-friendly parks on rise in SW Florida communities

Clever canine humor and real estate may seem a reach. But consider some park names and events. You have "Barkley Park," "Yappy Hours," "Barkingham Park" and that old stand-by "Dog Beach."

They all relate to pups and pooches and can be an important element for folks looking for a home in Southwest Florida.

"One of the things we found, in doing research for the Bonita Bay Group, is that pets are an integral part of people's lives, and we always had plans for a dog park," says Debbie Holm-Sheeley, general manager at Bonita Bay's Sandoval in Cape Coral, which opened Barkley Park about a year and a half ago in the 3-year-old development. "When we talk to people about purchasing at Sandoval, we find they love the idea of the dog park, so it's been a good component for us. We also have sidewalks, so people can walk their dogs."

Sandoval has areas for big and smaller dogs, just as Bonita Bay does at the Veranda. It will be the same at the just-opened Ave Maria.

"I'm not sure when they will be completed, but we'll have two dog tracks out there so we can segregate them by size," says Kelly Lawman, general sales manager at Ave Maria of a general recreation area. "I think that as people move into neighborhoods like Ave Maria, they really like the idea of parks. They have yards, but not the big, fenced-in yards like up north. So, it's a great way for the dogs to get exercise."

While the pets romp, their owners can get to know each other.

"There really is a social component to the dog parks," says Sandoval's Holm-Sheeley. "I remember, as kids, parents would take us to the playground and they got to know the other parents. It's the same with the dog parks, people can get to know each other and relax and chat while the dogs run around."

If a community doesn't have a designated dog park, some owners still manage to socialize and let their pets have fun as well.

"Some people have what they call 'yappy hours,' and meet at their community center or at a playground and bring their dogs or do a family dog day on a Saturday," says Ericka Basile, who has published the quarterly Naples Dog Magazine for two years. "On the government level, there's been a realization that people like dog parks and we see more and more of them."

Basile often sells advertising to Realtors who specialize in working with pet owners, "and they will help in finding pet-friendly condos or villas or other places."

Lee County has three designated dog parks and one beach.

"Dog Beach is at Blind Pass, south of Fort Myers Beach and it's been open about seven years," says John Yarbrough, director Lee County Parks and Recreation. "It's actually a sand bar and, at medium or low tide, there's probably about two acres of land. Basically, it's a beach and we don't provide any amenities."

You can take your dogs there and we have a sign of do's and don'ts for people who use the beach."

The newest county-run dog facility is Pooch Park at Judd Park in North Fort Myers. Dogs are also welcome at Barkingham Park, in Buckingham, and at the K-9 Corral at Estero Park. The county Web site - www.leeparks.org - has information on the dog-friendly parks including maps.

DOG TIPS

While many dogs like to frolic with other furry beasts, some would just as soon enjoy the great outdoors - albeit in a fenced-in park - as a solo experience.

Here are a few things for dog owners to consider if they go to a dog park, based on information published by the Lee County Parks Department and www.dogs.morefocus.com, which is filled with information on dogs.

- Owners must clean up after their dogs. Lee County provides bags and disposal stations.
- Dogs should have all their shots and be wearing tags.
- "We want sociable dogs that are not aggressive," says Lee County's John Yarbrough. "Dogs should also be spayed and neutered but we don't have Pet Police out there checking."
- Dogs in heat or puppies under 4 months old are prohibited.
- Be honest in assessing your dog's ability to play nice with others of various sizes.
- Never leave your dog unattended.
- Leash your dog when you leave the fenced-in area of a dog park.

Yarborough adds that they don't allow dogs in other parks, "and that is the case even if they are on a leash. We do allow them, if they are leashed, on the Ten Mile Linear Park."


Cape Coral also has a dog park at Rotary Park, 5505 Rose Garden Road, but dog lovers must register their pooches in advance and pay an annual fee: \$10 for residents, \$20 for nonresidents. For more information, go to capecoral.net.

Gulfside City Park w/Overlay of Sanibel Dog Park



Thank you for your attached correspondence of October 8, 2007. Pursuant to City Council's procedures, for an item to be placed on a Council agenda it must be sponsored by a City Council member.

You should be aware that neither the City of Sanibel's Parks and Recreation System Master Plan, the Sanibel Plan, nor the City's Comprehensive Land Use Plan, speak to the development of a dog park on Sanibel, nor is development of a dog park on City Council's goals for this upcoming year. A copy of City Council's current goals is attached.

Finally, your letter mentions endorsement by the Parks & Recreation Committee for a dog park. The Parks & Recreation Committee is advisory to City Council. Your letter does not mention after the consideration of the Park & Recreation Committee, on August 15, 2006, City Council made a decision to not pursue the feasibility of a dog park. A copy of the Council minutes is attached.

Vice Mayor Denham made a motion, seconded by Councilman Rothman, to direct staff to work with the Fire & Rescue District to rectify problems regarding delineators along the road.

The motion carried unanimously. Councilman Jennings was excused.

Staff report regarding parking alternatives for Clam/Dinkins Bayou

Ms. Zimomra gave background information.

Chief Bill Tomlinson spoke to working with staff to identify parking alternatives and the potential sites were as follows:

- Bowman Beach
- Blind Pass Marina
- End of Henderson Road
- San-Cap Culvert cut
- Silver Key Egress
- Los Colony

Staff recommended Bowman Beach or Blind Pass Marina and the other four sites were not appropriate for various reasons, i.e., safety, not enough room for turnarounds and environmental issues.

Discussion ensued regarding Bowman Beach parking gets people to Clam Bayou, but at low tide a person can't get to the water to kayak and if a dock was fixed this would solve the problem, Blind Pass Marina and the need for authorization for the City to use this for parking, Henderson Road had an area that is very wide and could be used, was there room to put parking on Henderson Road, and Mr. Duffy stated that the right of way was 50' and there were active permits on the north side of the right of way for single family construction. Further concern was the parking would have to be parallel to the right of way and bleed off could occur., and staff met with the owner of Blind Pass Marina and parking was at the marina for a fee, do not want to park on the right-of-way, get an agreement with Blind Pass Marina, staff could discuss with owner and bring back to Council, and Council agreed.

Requests from the Parks and Recreation Committee to authorize staff to do a feasibility study over the next three months of a location for a dog park on City-owned land

Council decided not to authorize staff to do a feasibility study.

Requests by Susie Marks to be appointed to the Vegetation Committee:

Councilman Brown made a motion, seconded by Councilman Rothman to appoint Susie Marks to the Vegetation Committee.

The motion carried unanimously. Councilman Jennings being excused.

Request to repair seawall and apply for grants at Bock Peace Park located at San Carlos Bay Drive

Mr. Castle spoke to the location being at the end of Dixie Beach Blvd. He explained that the seawall had previously been repaired and staff wanted to look at more permanent repairs. He further explained that staff requested and received proposals for three different options; 1) repair seawall and construct return - \$7000; 2) leave seawall and place rip rap - \$29,000; and 3) remove seawall and replace entirely with rip rap \$46,800. He further spoke to requesting TDC funding for maintenance of park.

Discussion ensued regarding if staff was requested TDC funding, and Mr. Castle answered yea.

Council in agreement.

Dear Judie,

I am President of the Sanibel Dog Club which has about 130 individuals who have signed a petition to establish a Dog Park on Sanibel (see attached Excel spreadsheet). The Sanibel Parks and Recreation Committee voted in 2006 to support a Dog Park. There is currently no location on Sanibel where a dog is allowed off a leash. There are many dog owners on the Island who would like a location where their canine friends can romp and play and get the exercise they need.

We would like to place the following request on the agenda for the City Council meeting on November 13 that: "The City of Sanibel support establishment of a dog park and investigate where it should be located."

We believe the Dog Park should be about 70 X 30 yards so that there would be adequate space for dogs to run and play and so that it could be divided into small and large animal areas. There would need to be adequate parking, as well as a water source.

The Sanibel Dog Club would be responsible for erecting a gate system and fence, provide plumbing for fresh water, and maintaining its cleanliness. There should be no cost to the city.

Possible areas to be considered:

Gulfside Park (Environmentally Sensitive Area – only for passive use – previously used for "Taste of the Island" event) – parking, water source available. The grass is mowed biweekly; new trees have been planted; the area is almost never used by either visitors or residents.

City Park, next to the Community Center – currently used for "Taste of the Island" and occasional other events (e.g. outdoor movie) – parking, water source available.

Area behind Schoolhouse Theater – Town Center development area – would require tree removal and relocation of recycle center – parking, water source available.

It is certainly possible that the City may find another area which is better than those listed above. We look forward to a cooperative relationship as this process proceeds.
