ORDINANCE 25-020 OF THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA, AMENDING THE CODE OF ORDINANCES, CHAPTER 66, TRAFFIC, ARTICLE II, PARKING, STOPPING AND STANDING, DIVISION 2, BEACH AREA PARKING RESTRICTIONS, SUBDIVISION II, PERMITS, SECTION 66-76, TYPES OF PERMITS, AND SECTION 66-85, FEES; HOURS; PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERANCE; AND PROVIDING AN EFFECTIVE DATE.

1. Summary of the proposed Ordinance:

The purpose of Ordinance 25-020 is to amend the civil penalties or fines established in Section 66-85 by establishing a First Offense penalty of \$250, plus a \$10 filing fee, and a Second Offense penalty of \$500, plus a \$10 filing fee. The penalty applies to boat ramp users who fail to pay for boat launching or retrieval without an annual or day beach parking permit, or unauthorized parking.

- 2. Estimate of the direct economic impact of the proposed Ordinance on private, for-profit businesses in Sanibel, including the following, if any:
