a. Natural Resources Staff Liaison Report

Staff Liaison Rainbolt spoke to Hurricane Helene and Milton recovery efforts from the Natural Resource Department. Ms. Rainbolt informed the committee that the Natural Resources Department has been working with the Public Works Department on the Tree City USA Designation Application. Discussion ensued regarding Tree City USA designation.

b. Chairperson's Report

Chair Boyce spoke to resilient plants and trees, storm surge and weirs education, and encouraging native plantings through the articles. Ms. Rainbolt advised the committee that they could educate but not provide services for planning or designing. Master Gardeners can do yard consultations for free and attend a class.
