RESOLUTION 25-037**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA, TO UPDATE RECREATION USER FEES BY AMENDING CHAPTER 90, FEES, ARTICLE V, RECREATION USER FEES; DIVISION 2, SANIBEL RECREATION CENTER; PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERANCE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, recreation user fees, including those for membership, rentals, and programs for the Sanibel Recreation Center, are set forth in Sanibel Code Chapter 90, Article V, Recreation User Fees; and

WHEREAS, in 2022, the City Council contracted the firm Berry Dunn McNeil & Parker, LLC (Berry Dunn) to provide professional services to complete a Recreation Comprehensive Assessment; and

WHEREAS, the Berry Dunn project managers presented their draft final report to the City Council on February 7, 2023, during a public meeting where public comment was received; and

WHEREAS, the Berry Dunn draft final report, titled "City of Sanibel Recreation Department Comprehensive Assessment, Analysis, and Evaluation Report" (Report) recommends that the City of Sanibel perform a recreation user fee analysis every two to five years; and

WHEREAS, the City Council approved Resolution 23-023 on April 12, 2023, accepting the Report and directing the City Manager to implement the Report's recommendations; and

WHEREAS, The Parks and Recreation Advisory Committee performed the two-year review of membership fees at its June 26, 2025, meeting and recommended the elimination of the 10 Punch Card and an increase in the non-resident membership fees; and

WHEREAS, the water slide and skate park have exceeded their useful lives and have been removed from the facility and are therefore no longer a rental option.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA:

SECTION 1. The recitals above are true and correct and made a part hereof.

SECTION 2. Chapter 90, Article V, Code of Ordinances, is hereby amended with ~~striketrough~~ language indicating deletions and underlined language indicating additions as follows:

SECTION 3. Codification. The City Manager is hereby authorized and directed to indicate these amendments in future City Code publications.

SECTION 4. Conflict. All ordinances and parts of ordinances in conflict herewith shall be and the same hereby repealed. If any part of this ordinance conflicts with any other part, it shall be severed, and the remainder shall have full force and effect and be liberally construed.

SECTION 5. Severance. If any section, subsection, sentence, clause, phrase or portion of this ordinance, or application hereof, is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion or application shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portion or application hereof.

SECTION 6. Effective date. This Ordinance shall be effective immediately upon adoption.
