I understand there is an upcoming presentation on managing the coyote attacks on sea turtle nests. I've been involved with enough of the SCCF programs to respect their assessment of the situation and what might need to be done to rebalance the predators.

I cannot make the Feb 3 presentation to personally take a position. I believe this situation has been well studied and a phased approach to identifying coyotes that have learned about this particular food source and habitually prey on the defenseless need to be culled and offset the damage to many.

My opinion is the success rate of sea turtle nests is statistically much lower than the survival of a handful of coyotes.

If it results in a systematic and managed killing or removal of a percentage of the coyote population so be it. It should be accomplished with measurable results and occur over time so one species is not driven to extinction.

Thinning of the heard is not a new strategy.

CROW, as a member of the Coyote Working Group, joins in the distress of our partners and the public regarding the loss of sea turtle eggs and hatchlings from coyote depredation on the islands. We appreciate the ongoing communication and exploration of alternative strategies by our partners; however, as a wildlife hospital whose mission is “saving wildlife” we must abstain from the targeted lethal removal discussion which will be presented to City Council. That said, please continue to count on us for research, education, and outreach as we work together to educate the residents and businesses on Sanibel and Captiva and beyond on community-based and prevention initiatives. We look forward to sharing our recommended communication strategies with you and the community in the coming weeks.
