Re: Charter Review-Proposed Annexation Amendment

Dear Mayors and Members of the City Council:

As you are aware, the Charter Review Commission recently discussed a proposed amendment regarding voluntary annexations. This drafted amendment was a result of my conversations with staff in an effort to address some of the concerns and ultimately negative effects with voluntary annexations out of the unincorporated areas and into City boundaries.

Some may recall that in August of last year, the Board of County Commissioners discussed this very issue at its August 2 Board meeting pertaining to an annexed parcel located at the Northeast Corner of Treeline Avenue and Daniels Parkway. As a result of that discussion the Board authorized sending a letter clarifying the County's position, which included safety concerns expressed by the County's Department of Transportation, along with utility services that the County was being asked to provide to the parcel that was now located within the City's municipal boundaries. During that Board meeting, it was expressed by County Management that this act of annexation should be of utmost concern to the County and highly prioritized going forward.

In presenting this recent proposal to the Charter Review committee, it was and remains my full intent to create an avenue for more dialogue between the six municipalities and the County. At times, we are contacted by concerned citizens within City boundaries, as was the case with the Daniels/Treeline parcel. This is an opportunity for local governments to have that open discussion for better planning and preserving our quality of life in our cities and County. I wholeheartedly support the City's Home Rule and ask that in turn you honor our County Home Rule.

I trust this writing makes clear my sincere intent for the benefit of the Cities and County working together to address voluntary annexation and in the best interests of all involved.
