

**CITY OF SANIBEL  
RESOLUTION 25-041**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA, TO DETERMINE THE PROPRIETY AND ADVISABILITY OF ESTABLISHING AND IMPLEMENTING THE ONE-TIME WULFERT CHANNEL AREA DREDGING ASSESSMENT DISTRICT; DECLARING, LEVYING, AND IMPOSING SUCH ONE-TIME SPECIAL ASSESSMENTS PURSUANT TO CHAPTER 170, FLORIDA STATUTES, THE FLORIDA CONSTITUTION, GENERAL LAW, AND THE SANIBEL CHARTER; PROVIDING FOR A ONE-TIME SPECIAL ASSESSMENT; PROVIDING CERTAIN PROCEDURES WHICH MAY BE USED BY THE CITY COUNCIL WITH RESPECT TO ASSESSMENT ROLLS; APPROVING COLLECTION OF ASSESSMENTS THROUGH INVOICING VIA THE CITY OF SANIBEL; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City Council adopted Resolution 25-024 on June 12, 2025, expressing the City's intent to declare a special assessment to finance a public improvement as authorized by the Home Rule provision of the Florida Constitution, Chapter 170, Florida Statutes, and other provisions of General Law and the Sanibel Charter, for the purpose of implementing dredging within an area referred to as the "Wulfert Channel Dredging Assessment District"; providing an estimated cost for said public improvements; providing an estimated assessment for each parcel within the Wulfert Channel Dredging Assessment District; providing a method and basis for the estimated assessment; providing for the method for the assessment collection; and

**WHEREAS**, the City Council adopted Resolution 25-034 on July 15, 2025, which amended the estimated project cost and estimated assessment for each parcel within the retitled "Wulfert Channel Area Dredging Assessment District" (the "Assessment District"); and established a public hearing date as required by Sections 170.07 and 170.08, Florida Statutes, for 9:10 A.M. on Tuesday, August 19, 2025 in the City of Sanibel, at MacKenzie Hall, Sanibel City Hall, 800 Dunlop Road, Sanibel, Florida, providing a time and place for the owners of the property to be assessed or any other persons interested to appear before the City Council and be heard as to the propriety and advisability of implementing the Assessment District and all matters related to assessments thereunder; and

**WHEREAS**, as required by Section 170.07, Florida Statutes, notice of a public hearing scheduled for August 19, 2025, has been published and, additionally, mailed to each Owner of property within the Assessment District, notifying each Owner of their opportunity to be heard regarding the assessment and all matters related thereto, and regarding the invoice by the City of Sanibel method of collection and all matters related thereto; and

**WHEREAS**, the noticed public hearing was held on August 19, 2025, and comments and objections of all interested persons have been heard and considered as required.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA;**

**SECTION 1. FINDINGS.**

The Sanibel City Council hereby finds and determines as follows:

- (a) The above recitals are true and correct and are hereby incorporated as findings.

- (b) The City Council declared its intent to establish and impose a one-time assessment for the dredging of certain portions of Wulfert Channel and Dinkins Bayou ("Wulfert Channel Area Dredging") pursuant to Resolution 25-024 adopted by the City Council on June 12, 2025, and Resolution 25-034 adopted by the City Council on July 15, 2025, both in accordance with Chapter 170, Florida Statutes.
- (c) All necessary notices required by Florida Statutes have been provided and all affected property owners have been provided the opportunity to provide written comments and objections, appear and speak at a public hearing scheduled for August 19, 2025, 9:10 a.m., with regard to the establishment and advisability of such one-time special assessment and all matters related thereto, and the collection of the assessment by the City of Sanibel invoicing, and all matters related thereto.
- (d) The one-time, equal imposition of a special assessment on parcels within the Assessment District to fund the dredging of Wulfert Channel is an equitable and efficient method of allocating and apportioning the costs of the Wulfert Channel Area Dredging among the parcels within the Assessed District.
- (e) The Preliminary Assessment Roll was made available for inspection by the public as required by Florida Statute, and the Final Assessment Roll for the Assessment District is hereby approved and attached as Exhibit A hereto.
- (f) A Public Hearing was held on August 19, 2025, and comments and objections of all interested parties have been heard and considered as required by Section 170.08, Florida Statutes (relating to the assessments) and to the method of collection by City invoicing.
- (g) Adoption of this Final Assessment Resolution constitutes a legislative determination that all parcels assessed derive a special benefit from the one-time special assessment for the dredging of Wulfert Channel, and a legislative determination that such assessments are fairly and reasonably apportioned among the properties that receive the special benefit as set forth in City of Sanibel Resolution 25-024 and Resolution 25-034, and this Resolution.
- (h) The method used for computing the one-time special assessment described in City of Sanibel Resolution 25-024 and Resolution 25-034 is hereby approved.
- (i) The method of collection for the one-time assessment against parcels within the Assessment District shall be completed utilizing invoicing by the City of Sanibel in accordance with the payment options detailed by the City Council in Resolution 25-024 and attached as Exhibit B hereto.

- (j) City of Sanibel Resolution 25-024 (Exhibit B) and Resolution 25-034, attached as Exhibit C hereto, are hereby confirmed and approved and are incorporated in this Resolution by reference.

## **SECTION 2. DEFINITIONS.**

“Final Assessment Resolution” means this City of Sanibel Resolution 25-041 establishing a one-time special assessment for Wulfert Channel dredging.

“Wulfert Channel Area Dredging Assessment District” means the Assessment District approved by this City of Sanibel Resolution 25-041, with such land area depicted and described in Exhibit D, attached hereto and incorporated herein, and includes all parcel within the Assessment District; however, excluding any vacant parcels that do not have dock development rights.

“Wulfert Channel Area Dredging” means proposed dredging for Wulfert Channel within the jurisdictional boundary of the City of Sanibel and areas between Wulfert Channel and the Henderson Road boat ramp that require dredging to provide the contractor performing the dredging work with a safe and navigable channel for equipment and barge access, as generally depicted in Exhibit E, attached hereto and incorporated herein.

## **SECTION 3. IMPOSITION OF A ONE-TIME SPECIAL ASSESSMENT COMMENCING THE 2025-2026 FISCAL YEAR.**

The City Council of the City of Sanibel, having conducted its public hearing pursuant to Section 170.08, Florida Statutes, to determine the advisability and propriety of establishing the Assessment District for the one time Wulfert Channel dredging, and funding thereof by a one-time special assessment pursuant to Home Rule Power, the Sanibel Charter, and general law, including without limitation Chapters 166, 170, and 180, Florida Statutes; hereby determines that it is proper and advisable to establish the Assessment District and impose a one-time special assessment against all parcels located within the Assessment District located within the City of Sanibel, Florida, and does hereby levy special assessment for the Fiscal Year commencing October 1, 2025 and ending September 30, 2026. The description of the one-time special assessment, the area to be assessed, and the cost and method of assessment are contained in Resolution 25-024 and Resolution 25-034, a copy of which is on file with the City Clerk, and hereby incorporated as reference. The assessments for all Assessed Property (parcels) are more particularly described in the Final Assessment Roll filed as part of the August 19, 2025, Public Hearing and incorporated herein as reference, subject to adjustments, if any, determined appropriate by the Sanibel City Council sitting this date as the Sanibel Equalization Board and reflected in a separate Resolution 25-043 adopted for that purpose. Such assessments are hereby confirmed, approved, and levied.

## **SECTION 4. FINAL IMPOSITION OF ASSESSMENT; LEVY, AND EFFECT OF**

**THIS FINAL ASSESSMENT RESOLUTION.**

The one-time special assessment for the Fiscal Year commencing October 1, 2025, and ending September 30, 2026, is hereby established upon adoption of this Final Assessment Resolution 25-041. This Final Assessment Roll for the Assessment District for Fiscal Year commencing October 1, 2025 and ending September 30, 2026, incorporated herein by reference, is hereby approved, subject only to adjustments, if any, by the Sanibel City Council sitting as the Sanibel Equalization Board. The adoption of this Resolution 25-041 shall be the final adjudication of the issues presented (including but not limited to, the method of apportionment and assessment, the rate of assessment, the Preliminary and Final Assessment Roll, the levy and lien of the one-time special assessment and the collection thereof through invoicing by the City of Sanibel), unless proper steps are initiated in a court of competent jurisdiction to secure relief within 20 days from the date of City Council adoption of this Resolution 25-041. The one-time special assessment imposed pursuant to this Resolution shall constitute a lien upon the Assessed Property equal in rank and dignity with the liens of all state, county, district, and municipal taxes and other non-ad valorem assessments. Except as otherwise provided by law, such liens shall be superior in dignity to all other liens, titles, and claims, until paid.

**SECTION 5. ADOPTION OF ONE-TIME ASSESSMENT RESOLUTION.**

- (a) This Resolution 25-041 and the Final Assessment Roll approved hereby, including any adjustments made by the Sanibel City Council sitting as the Sanibel Equalization Board pursuant to Resolution 25-043, shall constitute the authority for the assessments to be imposed and levied for the 2025-2026 Fiscal Year and the amounts set forth in such Final Assessment Roll are hereby imposed against all the Assessed Properties for this one-time special assessment.
- (b) As more particularly described in Resolution 25-024 and Resolution 25-034, incorporated herein by reference, each parcel within the Assessment District; excluding any vacant parcels that do not have dock development rights, shall be assessed based upon an assessable unit, which is defined as an existing dock or mooring space, berthing slip or the like, or the ability to legally place a dock or mooring slip on the parcel of property. Each parcel within the Assessment District has been deemed to have one assessable unit based upon the fact that such parcels either have, or is legally entitled to have, a minimum of one dock. This results in a total one-time assessment of \$2,556.47 for each parcel. It has been estimated that the one-time assessment of \$2,556.47 should be sufficient to fund the Wulfert Channel dredging project. The \$2,556.47 assessment per parcel may not be increased unless the City Council initiates the required notifications, publications, and public hearings to advise the owners of parcels within the Assessment District that an increase in the assessment per parcel is being considered by the City Council. Such publications, mailed individual notices, and public hearing requirements are set forth in Section 1, subsections (b) through (f),



above, and all affected property owners shall have the opportunity to be heard at the appropriately noticed public hearings before any increase in the one-time assessment per parcel could occur.

- (c) As further described in Section 3 of Resolution 24-024, and Section 1 of Resolution 25-034, 66.67% of the total costs of the Wulfert Channel Dredging project shall be paid by assessments levied against each parcel located within the Assessment District and 33.33% of such total costs of the Wulfert Channel Dredging project shall be paid by the City of Sanibel. Pursuant to Section 5(b) of this Resolution 25-041, the assessment of \$2,556.47 per parcel within the Assessment District has been estimated to generate sufficient funds to fund the 66.67% share of the project costs charged to the total number of parcels within the Assessment District.

The current estimate for total costs of the Wulfert Channel dredging project initiated in Fiscal Year 2025, as specified in Section 1 of Resolution 25-034 is \$748,065.

#### **SECTION 6. APPROVAL AND DESIGNATION OF THE COLLECTION OF INVOICING BY CITY OF SANIBEL METHOD OF COLLECTION.**

- (a) The Sanibel City Council determines that it is appropriate to collect and enforce such assessments through invoicing by the City of Sanibel.
- (b) As provided for in Section 3(b) of Resolution 25-024, the assessment of \$2,556.47 per parcel within the Assessment District shall be paid in lump-sum in 2025, or in installments of 2, 3, 4, or 5 annual payments, plus interest of 4.5% compounded annually. The annual installment amounts are provided in Exhibit F, attached hereto.
- (c) Upon approval of this Resolution 25-041, the City Manager shall by letter notify each parcel owner within the Assessment District of their option on elect to pay the assessment of \$2,556.47 in one lump-sum payment in 2025, or in installments of 2, 3, 4, or 5 annual payments, plus interest of 4.5% compounded annually. Said letter notification shall be sent to each parcel owner within the Assessment District to the names and addresses of such property owners as obtained from the public records of the Lee County Property Appraiser. Parcel owners shall be granted 30 days to respond to the City Manager's letter, in writing by email or letter, to the addresses provided within the City Manager's letter. In the event a parcel owner fails to respond in writing to the City Manager's letter within 30 days, the parcel owner shall be invoiced for payment of the \$2,556.47 assessment in one lump-sum payment in 2025.

**SECTION 7. EFFECTIVE DATE.** This Resolution shall take effect immediately upon adoption.

### **CITY OF SANIBEL RESOLUTION 25-024**

**A RESOLUTION EXPRESSING THE INTENT OF THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA, TO DECLARE A SPECIAL ASSESSMENT TO FINANCE A PUBLIC IMPROVEMENT AS AUTHORIZED BY THE HOME RULE PROVISION OF THE FLORIDA CONSTITUTION, GENERAL LAW, AND THE SANIBEL CHARTER; ESTABLISHING A SPECIAL ASSESSMENT FOR THE PURPOSE OF DREDGING IN THE WULFERT CHANNEL AND DISPOSAL OF DREDGE MATERIALS, WITHIN AN AREA TO BE REFERRED TO AS THE "WULFERT CHANNEL AREA DREDGING ASSESSMENT DISTRICT"; ADOPTING THE PROCEDURES SET FORTH IN CHAPTER 170, FLORIDA STATUTES; PROVIDING FOR A DESCRIPTION OF THE NATURE AND LOCATION OF THE IMPROVEMENT, THE MANNER OF LEVYING AND COLLECTING ASSESSMENTS, SPECIFYING THE PORTION OF THE ASSESSMENT TO BE PAID BY THE CITY TO ACCOUNT FOR GENERAL PUBLIC BENEFIT ACCRUING FROM THE PROJECT, THE ESTIMATED COST, AND THE DESCRIPTION OF THE LANDS UPON WHICH THE ASSESSMENT SHALL BE LEVIED; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Sanibel wishes to establish an assessment district for dredging of the Wulfert Channel Area located within the City of Sanibel, hereinafter referred to as the Wulfert Channel Dredging Assessment District (hereinafter sometimes referred to as the "Assessment District") and shown on the map attached as Exhibit "A"; and

**WHEREAS**, dredging within the Assessment District is a public improvement, and the City is establishing the Assessment District pursuant to its Home Rule Power, the Sanibel Charter, and general law, including without limitation Chapters 166, 170, and 180, Florida Statutes; and

**WHEREAS**, Section 170.03, Florida Statutes, provides that a municipality making public improvements when utilizing special assessments shall adopt a resolution stating the nature of the improvement, the location of the improvement, the part or portion of the expense to be paid by the special assessments, the manner in which said assessments shall be made, when said assessments are to be paid, what portion, if any, is to be paid from the general improvement fund of the municipality, a designation of the lands upon which the assessments shall be levied, and the total estimated cost of the improvement.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA:**

**Section 1. Determination of Need for Special Assessments; Description of the District.** The City Council of the City of Sanibel hereby makes a finding of the need for the levy of special assessments within the Assessment District for the public improvement project to include the dredging of the Wulfert Channel Area and the disposal of dredge material. Such special assessments shall be applicable within the Assessment District, which lands within such Assessment District are depicted on Exhibit "A" and generally described on Exhibit "B" (both exhibits attached hereto and incorporated herein). The Assessment District shall be a single special assessment district.

**Section 2. Description of the Project.** A more specific description of the dredging improvement project for which the special assessments are being levied and collected (hereafter sometimes referred to as the "Project") is as follows:

- (a) To provide collected funds for the one time dredging and material haul from the Wulfert Channel Area (depicted on Exhibit "A") to provide bay and gulf access to all properties within the Assessment District. The dredging will occur one time in order to provide for navigability by owners, lessees, and the general public through the Wulfert Channel Area, and to protect the health, safety, and welfare of the adjacent owners and public in general; and

**Section 3. Costs and Payment.** The total cost of surveying, dredging, material hauling, financing and interest (if any), engineering (if any), legal costs (if any), permit fees, and administrative costs for the Project (hereinafter "Total Estimated Project Cost") is currently estimated to be \$718,000 for the 2025 Project. Cost-sharing for the Project shall be as follows:

- (a) A portion equaling 33.33% of the Total Estimated Project Cost shall be paid by the City and shall be budgeted by the City annually, as follows:

Total Estimated Project Cost: \$446,065.00, with City Estimated Cost (33.33%) of \$148,673.46, to be paid from the general fund in FY 2025.

- (b) A portion equaling 66.67% of the Total Estimated Project Cost shall be paid by assessments levied each year against the real property located within the Assessment District, as follows:

Total Estimated Project Cost: \$446,065.00, with Private Property Estimated 2025 Cost (66.67%): \$297,391.54, to be divided equally among the owners of each parcel within the Assessment Area, estimated to be 196 parcels, and paid in lump-sum in 2025 in the amount of \$1,517.30, or in installments of 2, 3, 4, or 5 annual payments, plus interest of 4.5% compounded annually. The annual installment amounts are provided in Exhibit "C"; and

**Section 4. Method and basis for assessment.** Each parcel within the Assessment District shall be assessed based upon an assessable unit. An assessable unit is defined as an existing dock or mooring space, berthing slip or the like, or the ability to legally place a dock or mooring slip on the parcel of property.

- (a) Each parcel (either vacant or improved) shall be deemed to have one assessable unit based upon the fact that such parcel either has, or is legally entitled to have, a minimum of one dock. However, any vacant parcels within the proposed Assessment District that do not have development rights will be excluded.
- (b) The City shall pay its 33.33% of the Project as described in Section 3 of this Resolution.

**Section 5. Single assessment to be authorized.** This Assessment District shall be established as a one time, single capital improvement and service assessment district which shall provide a funding source for the dredging of the Wulfert Channel Area. It is specifically determined and found by the City Council that this one time capital improvement and service assessment district is necessary, appropriate, and the best method by which to address the need for the survey, dredging, and disposal of dredge material for the Wulfert Channel Area, with the single assessment of the costs described herein to be made in 2025 against the properties benefited thereby.

The methodology and the amount of the yearly assessment for each property shall be set forth in a Preliminary Assessment Roll, a copy of which shall also be kept on file with the City Clerk and available for public inspection and which will be presented to the City Council at a public hearing to establish the Assessment District. The assessment collection for the 2025 Project will be collected directly by the City of Sanibel.

**Section 6. Intent to establish Assessment District.** The City Council hereby declares and evidences its intent to make such public improvements as described in this Resolution and to finance such improvements and the Project through, in part, a levy and special assessment against all lots and lands adjoining and contiguous, or bounding and abutting upon said improvements, or specially benefited thereby, and further designated by the Assessment Plat attached hereto as Exhibit "A" and on file in the office of the Sanibel City Clerk. The plans and specifications for the 2025 Project, as well as an estimate of the cost of the Project improvements are on file with the City Clerk, Sanibel City Hall, 800 Dunlop Road, Sanibel, Florida, 33957, as of the date of adoption of this resolution.

**Section 7. Publication of Resolution.** The City Clerk is directed to publish this resolution one time in a newspaper of general circulation published in the City of Sanibel, or as otherwise may be required by law.

**Section 8. Effective Date.** This resolution shall take effect immediately upon adoption.

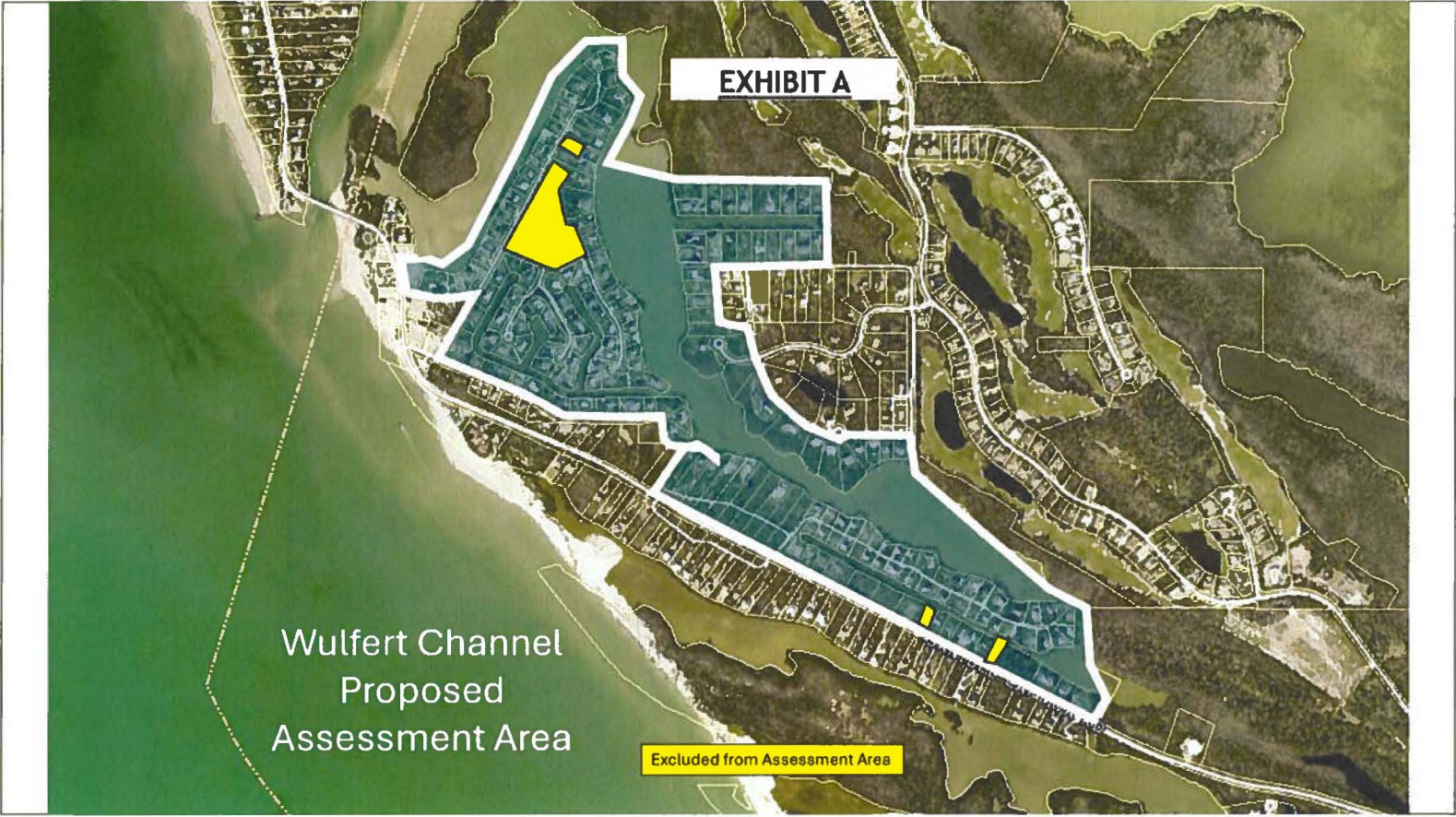

### **CITY OF SANIBEL RESOLUTION 25-034**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA, AMENDING COST ESTIMATES RELATED TO PROPOSED DREDGING WITHIN AN AREA REFERRED TO AS THE "WULFERT CHANNEL AREA DREDGING ASSESSMENT DISTRICT"; TO FIX A TIME, DATE, AND PLACE FOR A PUBLIC HEARING IN ACCORDANCE WITH SECTIONS 170.07 AND 170.08, FLORIDA STATUTES, TO DETERMINE THE PROPRIETY AND ADVISABILITY OF ESTABLISHING AND IMPLEMENTING THE WULFERT CHANNEL AREA DREDGING ASSESSMENT DISTRICT; AND, IF DETERMINED TO BE PROPER AND ADVISABLE TO ESTABLISH SUCH DISTRICT, TO FURTHER DETERMINE THE COST OF SUCH DREDGING-RELATED EFFORTS, THE MANNER OF PAYMENT FOR SUCH EFFORTS, AND THE AMOUNT OF SUCH COSTS TO BE ASSESSED AGAINST EACH PROPERTY WITHIN THE DISTRICT; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City Council of the City of Sanibel adopted Resolution 25-024, which expressed the City's intent to declare a special assessment to finance a public improvement as authorized by the Home Rule provision of the Florida Constitution, Chapter 170, Florida Statutes, and other provisions of General Law and the Sanibel Charter, for the purpose of implementing dredging within an area referred to as the "Wulfert Channel Dredging Assessment District," more accurately described in Exhibit A hereto (the "Assessment District"), and to make assessments against property within the Assessment District to aid in the funding of such public improvement; and

**WHEREAS**, the assessment amounts in Resolution 25-024 were premised on an estimated dredging cost of \$446,065 but with the understanding additional areas within the Dinkins Bayou area of the Assessment District may require dredging to allow the dredging barge, once filled with dredge material, to navigate between Wulfert Channel and the Henderson Boat Ramp; and

**WHEREAS**, upon further review and investigation, it has been determined that additional dredging within the area within the Dinkins Bayou area of the Assessment District is, in fact, required, such that the amended estimated costs of dredging-related work within the Assessment District now totals \$748,065; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA;**

**SECTION 1.** The amended estimated assessment cost for the dredging-related work within the proposed Wulfert Channel Dredging Assessment District for Fiscal Year 2024-2025 is Seven Hundred Forty-Eight Thousand, Sixty-Five Dollars (\$748,065).

**SECTION 2.** A public hearing is hereby established and scheduled as required by Sections 170.07 and 170.08, Florida Statutes, for 9:10 A.M. on Tuesday, August 19, 2025 in the City of Sanibel, at MacKenzie Hall, Sanibel City Hall, 800 Dunlop Road, Sanibel, Florida, to provide a time and place for the owners of the property to be assessed or any other persons interested appear before the City Council and be heard as to the propriety and advisability of implementing the Assessment District and if determined to be proper and advisable to establish such Assessment District, to further determine the cost of such dredging-related efforts, the manner of payment for such efforts, and the amount of such costs to be assessed against each property within the Assessment District through invoicing by the City of Sanibel.



**SECTION 3.** Effective date. This Resolution shall take effect immediately upon adoption.


