**“RULES OF CIVILITY FOR PUBLIC PARTICIPATION”**

**In recognition that public discourse is essential to the democratic system of government on April 16, 2002, Sanibel City Council adopted a Proclamation embracing civility in public deliberations. These rules were updated February 22, 2007.**

**Therefore, Sanibel City Council sanctioned these rules for public participation while conducting meetings and workshops:**

- 1. Speakers are permitted to deliver his or her comments without interruption.**
- 2. Speakers and debates should focus on issues, not on persons or personalities.**
- 3. Persons are encouraged to participate in the governmental process.**
- 4. To allow time to hear all points of view, speakers are allotted 3 minutes each time they are recognized.**
- 5. Sidebar discussions while others are speaking are not permitted in Council Chambers. These discussions are to be removed from the chamber so as not to be disruptive to those conducting and following Council business.**
- 6. Only the speaker recognized by the Chairperson has the floor. Speakers should raise their hand to be recognized. Speakers should identify themselves for the record. Speakers should utilize the microphone so that their comments can be recorded.**
- 7. Anyone wishing to speak on an issue is given an opportunity to speak before speakers are recognized for an opportunity to speak a second time on an issue.**
- 8. We seek to understand one another’s points of view.**
- 9. Anger, rudeness, ridicule, impatience and lack of respect for others are not acceptable behavior. Demonstrations in support or opposition to a speaker or idea such as clapping, cheering, booing or hissing or intimidating body language are not permitted in Council Chambers or workshop facilities.**
- 10. We should all take initiative to make things better. Our goal is to foster an environment, which encourages a fair discussion and exchange of ideas without fear of personal attacks.**

**SUBJECT:** Fiscal Year 2023 Budget Adoption

**BACKGROUND:** At the September 12, 2022 first budget hearing, the City Council approved Resolution 22-048 which adopted a tentative operating millage rate for the General Fund of 1.9750 mills and an aggregate millage rate (inclusive of the two voted debt issuances) of 2.1523 mills.

The City Council also approved Resolution 22-049 which adopted a tentative total City-wide budget of \$84,029,407.

The purpose of the final budget hearing is for the City Council to take public input and vote to approve a final operating millage rate, total voter approved debt millage rates and a City-wide budget for all funds.

Based on the resolutions approved at the first budget hearing, Resolution 22-050 would approve an operating millage rate of 1.9750, which is 17.62% higher than the rolled back rate for fiscal year 2023 and voter approved debt issuance of 0.0858 mills for the sewer system and 0.0915 for the recreation center construction. Resolution 22-051 would approve a total City-wide budget of \$84,029,407.

**BACKGROUND:**

The Capital Improvements Review Sub-Committee met on September 6, 2022, to conduct an annual review of the capital improvements element of the Sanibel Plan and the 5-year capital improvements plan, as required by Chapter 163 of Florida Statutes and Sec. 82-281 of the Sanibel Land Development Code. Sec. 82-281 establishes six criteria for the annual review:

- (1) *A review of current costs and revenue and possible corrections and modifications to the capital budget suggested or required as a result of such review.*
- (2) *The capital improvements element's consistency with other elements of the Sanibel Plan.*
- (3) *A determination, based on the forecast of costs and revenues, of the economic feasibility of the Sanibel Plan.*
- (4) *The city's progress in reducing any existing deficiencies of the established levels of service for such public facilities.*
- (5) *A recommendation as to assignment of priorities with respect to scheduled capital improvements.*
- (6) *A review to determine the effectiveness of the city's ability to maintain adopted level or service standards.*

The Sub-committee made the following recommendation to the Planning Commission:

*Commissioner DeBruce moved, seconded by Commissioner Nichols to make the recommendation to the Planning Commission, finding the Capital Improvement Plan is consistent with the Sanibel Plan, touching on the priorities of the Sanibel Plan, requiring no additional projects in order to implement the plan that are not already in the works, there being no existing deficiencies in the established levels of service for sanitary sewer, solid waste, drainage or potable water, continued emphasis on completing the Police Department modernization project and updates to the Recreation Master Plan, and there being no existing or projected deficiencies in the adopted level of service standards for public facilities. The motion carried.*

The Planning Commission reviewed the recommendation from the Sub-committee at its meeting of September 13, 2022, and voted to forward the recommendation to City Council.

**RECOMMENDED ACTION:**

City Council should consider the recommendation of the Planning Commission at its meeting of September 28, 2022.

**WHEREAS**, the gross taxable value for operating purposes not exempt from taxation within the City of Sanibel, Florida has been certified by the Lee County Property Appraiser to the City of Sanibel as \$6,357,621,055.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA:**

**Section 1.** Operating Millage. The Final Ad Valorem Operating Millage Rate for Tax (Calendar) Year 2022 is hereby adopted at \_\_\_\_\_ mills and the levy of an annual tax for said year is made. The final operating millage rate exceeds the rolled-back rate of 1.6792 mills by \_\_\_\_\_%.

**Section 2.** Voted Debt Service Millage Rates.

- a. The Final Sewer Voted Debt Service Millage Rate for Tax (Calendar) Year 2022 is hereby adopted at 0.0858 mills and the levy of an annual tax for said year is made.
- b. The Final Recreation Center Voted Debt Service Millage Rate for Tax (Calendar) Year 2022 is hereby adopted at 0.0915 mills and the levy of an annual tax for said year is made.






