RESOLUTION 25-036

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA, APPOINTING FIVE MEMBERS TO SERVE ON THE TRANSPORTATION MASTER PLAN UPDATE STEERING COMMITTEE UNTIL THE CITY COUNCIL ACCEPTS THE PLAN AND THE COMMITTEE IS DISSOLVED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Resolution 25-033 established the Transportation Master Plan Update Steering Committee and provides that five members are to be appointed by the City Council and serve until the Committee is dissolved once the Transportation Master Plan has been accepted by city Council; and

WHEREAS, Resolution 25-033 also provides that the composition of the Committee be as follows: one Planning Commissioner; one Sanibel Captiva Conservation Foundation member; one Sanibel Captiva Chamber of Commerce member (staff or Board member); one Committee of the Islands member; and one citizen-at-large to be appointed by City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SANIBEL, FLORIDA:

SECTION 1. The following persons are hereby appointed to the Transportation Master Plan Steering Committee:

Evelyn Stewart - Sanibel Captiva Chamber of Commerce


Pasquale Russo – Citizen-at-Large


