Post Hurricane Ian Sanitary Sewer Cleaning and CCTV Inspection – Phases 2 & 3

BACKGROUND: After Hurricane Ian, the City received \$10,000,000 in funding from the State of Florida as part of the Hurricane Ian Wastewater Collection System Repairs grant program under agreement HA036. As part of this funding, the City contracted Tetra Tech, Inc. to prepare bid documents for procurement of gravity sanitary sewer pipe cleaning and Closed-Circuit Television (CCTV) contractor services.

Construction - Post Hurricane Ian Sanitary Sewer Cleaning and CCTV Inspection - Phase 2

An Advertisement for bids was placed in the April 16, 2025 edition of the Fort Myers News- Press and with the City's online bid solicitation service, DemandStar. Bid opening was conducted by City Staff on May 14, 2025 at 2:30 PM in the presence of Alfred J. Mittl, P.E., Public Works Director and Jason Goodrich, Deputy Utilities Director. There were 11 bids submitted with the low bid submitted by EnviroWaste Services Group, Inc. with a total of \$565,375.00 as shown in the attached bid summary prepared by Tetra Tech, Inc. The bids remain valid for 60 days.

Construction - Post Hurricane Ian Sanitary Sewer Cleaning and CCTV Inspection - Phase 3

An Advertisement for bids was placed in the April 16, 2025 edition of the Fort Myers News- Press and with the City's online bid solicitation service, DemandStar. Bid opening was conducted by City Staff on May 15, 2025 at 2:30 PM in the presence of Alfred J. Mittl, P.E., Public Works Director and Jason Goodrich, Deputy Utilities Director. There were nine (9) bids submitted with the low bid submitted by EnviroWaste Services Group, Inc. with a total of \$587,010 as shown in the attached bid summary prepared by Tetra Tech, Inc. The bids remain valid for 60 days.

Construction Administration

Tetra Tech, Inc. has a Professional Services Agreement with the City of which was entered into on October 3,2023 and is valid through September 30, 2028. Tetra Tech, Inc. will provide construction administration and inspection services. The detailed services Tetra Tech, Inc. will provide to the City are described in the firm's proposal that was approved by Council August 20, 2024, and is included in the agenda packet.

FUNDING SOURCE: Funding requirements for the project are discussed above. The fiscal year 2025 adopted capital budget includes \$1.5 million in wastewater system repairs.

The Tables below summarize:

- The FY2025 Project Funding Summary (rounded) illustrates that \$1.5 million was appropriated from the \$10 million FDEP grant for Collection System Repair projects and what has been spent, FY to date, against the FY25 appropriation. An additional \$477,150 was added to the project budget via Resolution 24-069 which accounted for FY24 projects that were rolled into the FY25 budget.
- 2. The FDEP Wastewater Collection System Repairs Grant Summary (rounded) illustrates how much of the \$10 million FDEP grant has been spent, FY to date.
