

**CITY OF SANIBEL, FLORIDA
RESOLUTION 21-065**

A RESOLUTION ADOPTING AND ESTABLISHING A REVISED SCHEDULE OF RATES FOR THE SANIBEL SEWER SYSTEM AND PROVIDING FOR A 1.0% INCREASE IN RESIDENTIAL, COMMERCIAL, AND RECLAIMED WATER RATES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Sanibel Code provides for the adoption of Sanibel Sewer System rates, fees and charges by resolution; and

WHEREAS, Resolution No. 20-063 dated September 14, 2020 established the rate structures for the fiscal year which began on October 1, 2020; and

WHEREAS, the City Council finds it appropriate and necessary to provide for a sewer and reclaimed water rate adjustment increase of 1.0% for the fiscal year beginning October 1, 2021;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Sanibel, Florida:

SECTION 1. The City Council hereby adopts and approves the following rate schedule for the fiscal year beginning October 1, 2021:

A. Sewer System Rates:

1. RESIDENTIAL CUSTOMER RATES (per dwelling unit):

3. The above schedule does not include, and is not intended to address or amend sewer assessments, connection or transmission charges, guaranteed revenue charges, nor any other related sewer charges not specifically referenced above.

B. General Reclaimed Water Rates: \$3.06 per 1,000 gallons

1. The above does not include, and is not intended to address or amend, golf course bulk rates, service connection fees, nor any other related charges not specifically referenced above.

SECTION 2. Preexisting Schedules. This schedule supersedes and amends the presently existing approved rates, fees and charges as previously established by Resolution No. 20-063. However, it does not repeal or affect rates, fees and charges properly charged under previous schedules or subject to lawful preexisting agreements.

SECTION 3. Effective date. This resolution shall take effect immediately upon adoption.
