**A RESOLUTION ESTABLISHING THE SANIBEL CITY COUNCIL  
REGULARLY SCHEDULED MEETING DATES FOR THE 2022 CALENDAR  
YEAR; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Section 3.09 of the Charter of the City of Sanibel provides that the City Council shall meet regularly at least once every month; and

**WHEREAS**, the City Council wishes to establish its regular meeting schedule for the 2022 calendar year; and

**WHEREAS**, the City Council finds such regular meeting schedule to be appropriate and necessary for the conduct of the City's governmental business;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Sanibel, Florida, that:

**SECTION 1.** The dates set forth on Exhibit "A", attached hereto and incorporated herein, are hereby designated and established as the regular monthly Sanibel City Council meeting dates for the 2022 calendar year. Such meeting dates shall constitute the only regularly scheduled City Council meeting dates during such time period and any meeting date not specifically set forth, whether previously scheduled or otherwise, shall be deemed canceled.

**SECTION 2.** Effective date.

This Resolution shall take effect immediately upon adoption.


