

**CITY OF SANIBEL  
RESOLUTION 21-073**

**A RESOLUTION DETERMINING THE RENEWAL OF AN ENTERTAINMENT  
LICENSE AT THE BLUE GIRAFFE RESTAURANT AT BEACHVIEW ESTATES  
LOCATED AT 1100 PAR VIEW DRIVE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the applicant, William Letendre of Letendre Enterprises, owner of the Blue Giraffe Restaurant, filed an application on December 22, 2020 requesting an indoor musical entertainment license to provide entertainment as described in Section 1 below; and

**WHEREAS**, the Council adopted Resolution 21-007 approving an entertainment license which will expire on September 30, 2021; and

**WHEREAS**, this Council has duly heard and considered the renewal request for the entertainment license.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Sanibel, Florida:

**SECTION 1.** The application of the Blue Giraffe Restaurant for an entertainment license in conjunction with its business tax receipt at the Blue Giraffe Restaurant, 1100 Par View Drive, Sanibel, is hereby approved with the following conditions:

- a. Performances under this approval are limited to no more than one musician at a time.
- b. All performances must be inside the Blue Giraffe Restaurant building.
- c. Entertainment only permitted between 5:00 P.M. and 9:00 P.M.
- d. The annual entertainment business receipt tax is \$262.50 per year, unless revised by Council resolution or ordinance.
- e. Unless the City Manager refers the matter to Council due to excessive noise, non-compliance with City laws and regulations, or other issues related to the license, the license may be renewed annually, at the time other business tax receipts are issued, without further Council action. In the event that the City Manager refers the matter to City Council for any reason set forth herein, the entertainment license shall only be renewed upon review and approval by City Council, and without such approval, such license shall terminate at the end of the license year, unless terminated earlier by action of the City in accordance with the City's Local Business Tax Ordinance and this Resolution.

**SECTION 2.** Effective Date.

This resolution shall take effect immediately upon adoption.
