RESOLUTION 21-063

A RESOLUTION APPROVING AND ADOPTING THE 2020 LEE COUNTY MULTI-JURISDICTIONAL PROGRAM FOR PUBLIC INFORMATION FOR AND IN COMPLIANCE WITH THE NATIONAL FLOOD INSURANCE PROGRAM; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Sanibel desires to have in place the 2020 Lee County Multi-Jurisdictional Program for Public Information in compliance with the National Flood Insurance Program; and

WHEREAS, the City established the City of Sanibel Floodplain Management Planning and Mitigation Advisory Committee on May 3, 2016 and was a committee composed of six (6) members, each of whom had expertise in one or more of the following categories of activities: Preventative measures (e.g. codes), property protection (e.g. elevation), natural resources protection, emergency services, structural flood control projects, public information and such committee has at least one member of the general public; and

WHEREAS, the City of Sanibel Floodplain Management Planning and Mitigation Advisory Committee approved and recommended to City Council the adoption of the 2020 Lee County Multi-Jurisdictional Program for Public Information; and

WHEREAS, the City Council finds it necessary and appropriate to adopt the 2020 Lee County Multi-Jurisdictional Program for Public Information in order to comply with necessary regulations for the National Flood Insurance Program Community Rating System and related regulations; and

WHEREAS, the 2020 Lee County Multi-Jurisdictional Program for Public Information was updated to reflect changed conditions, the progress made in implementing the program, and further provided direction for future actions on the part of the City; and

WHEREAS, the City of Sanibel Floodplain Management Planning and Mitigation Advisory Committee approved the 2020 Lee County Multi-Jurisdictional Program for Public Information dated August 2020 to welcome public information in advance of the submittal to the City Council for approval;

NOW, THEREFORE, BE IT RESOLVED by City Council of the City of Sanibel, Florida, that:

SECTION 1. The 2020 Lee County Multi-Jurisdictional Program for Public Information, a copy of which is attached hereto and incorporated herein as Exhibit "A", is hereby approved and adopted.

SECTION 2. Effective date.

This Resolution shall take effect immediately upon adoption.
