Writing to you on two items. First, please advised that consideration of the Application from the Historical Museum & Village to serve Alcohol on City Grounds on 12/2/2021 will

be on the City Council agenda at their next meeting, **9 am, Monday, September 13th** . The City Council agenda will be posted tomorrow. Based upon the current COVID surge, please advise as to what protocol protocols you are planning to incorporate into your event.
